Dave and Ann Lund have made Northeast their life's work. Ann started working full time at the College in July of 1980. She is in her 40th year! Dave did construction for a few years and began working full time at the College in 1984.

Each of Dave and Ann's three sons, Adam, Aaron and Anthony, attended Northeast Community College. Their middle son, Aaron, completed one year in the drafting program at Northeast and was doing his internship the summer of 2007 when he tragically drowned.

Dave and Ann talked about starting a scholarship in Aaron's memory. They wanted to help others be able to afford a chance at college. Ann feels that having established this scholarship has absolutely given them comfort. The college and their co-workers provided much needed support for the Lunds in their grief.

So with the Aaron Lund Memorial Drafting Scholarship in place, what caused Ann and Dave to put Northeast Community College in their estate plans? Ann stated simply, "Northeast is just family."
