Terms and Conditions

Meal Plan: The Off-Campus meal plan contract will observe Northeast Community College's (NORTHEAST) academic calendar. Dates are subject to change. If an Unlimited meal plan participant chooses not to use all their meals each semester, the remaining balance will be forfeited at the end of each semester. Participants on the 10 Meals per Week meal plan will lose any uneaten meals at the end of each week, with the weeks running from Monday morning to Sunday evening. Uneaten meals as of Sunday evening following dinner will be forfeited. If Express Cash participants have a positive balance remaining at the conclusion of the academic year, the remaining balance will be forfeited. NORTHEAST and the food service Contractor are not responsible for lost or stolen Express cards.

1. Students may add to, cancel, or change their meal plan contract before the beginning of a semester or during the first week of classes only. Students will not be allowed to change or cancel their meal plan contract during that semester.
2. A student suspended or expelled from NORTHEAST shall not receive a refund and shall not utilize the meal plan program upon notification of the suspension or expulsion.
3. Students who officially withdraw from NORTHEAST may be eligible for a meal plan refund. The refund will be prorated through the end of the week of the official withdrawal date. The food service Contractor will offer prorated meal plans when given reasonable advance notice by students who will miss weeks of food service because of military leave.
4. In the case of prolonged illness, a prorated refund may be given for days in excess of the first 14 days of illness. The written requests must be sent to the Executive Director of Student Success within two weeks of the illness and include a doctor's written verification.
5. Consumption Policy: The following actions by a student on the meal plan will not be allowed:
 - a. Taking food product(s) out of the cafeteria area. Exceptions may be made for COVID-19 related guidelines.
 - b. Flagrant wastefulness of food.
 - c. Any student found violating the consumption policy will be held accountable according to the Northeast Community College Student Code of Conduct.
6. Meal Plan Program Exceptions:
 - a. During official College breaks, the dining hall facility will be closed following lunch on the day prior to the break until the Sunday night before classes resume. The grill at Hawk's Point and Jazzy's Corner Store may be closed or open for reduced hours during college breaks. If open, the times will be posted by the food service Contractor. Cash, credit/debit, or Express Cards may be used to purchase meals.

Liability

1. NORTHEAST accepts no responsibility for the theft or other loss of money, valuables, or any damage occurring to the personal belongings of the student.
